The Facility will be used to refinance the Group's existing indebtedness and to finance the corporate funding requirements of the Group.

Pursuant to the terms of the Facility Agreement, it shall be a mandatory prepayment event if any of the following events occurs: (i) Mr. Wong Leung Pak, Matthew, BBS ("**Mr. Wong**") and/or his successor ceases to own at least 50.1% of the entire issued share capital of the Company; or (ii) Mr. Wong ceases to be the chairman of the Company and to maintain control over the management and business of the Group.
